Fiscal Year 2019 was characterized by a synthesis of purpose resulting from the Maui School Garden Network's (MSGN) merger with Grow Some Good. This merger facilitated significant advancements in our ability to offer garden and nutrition programs to schools, teacher training, social media coverage, and community alliances with organizations such as Blue Zones and HEAL (Healthy Eating, Active Living). Our Maui County Grant under OED provided the opportunity to reach out, particularly into ECE (early childhood education), and expand our offerings to intermediate school students and teachers. Also, as a result of the merger, the work of MSGN continued through a funded, new Program Manager position.

We fiscally sponsored Ho'aloa Aina, a grassroots organization that organizes volunteer efforts on Maui.

Due to COVID 19, we leveraged our current garden education programming and extended it to families and other community members through our Plant and Food Distribution project. With the help of our community coalition members and numerous volunteers, we grew and distributed 5,741 plants, 680 pounds of fresh produce, and served at least 450 families during the final quarter of our fiscal year.
